WE ALSO PROVIDE PROGRAM GRADUATES WITH EDUCATIONAL SCHOLARSHIPS IN CASES WHERE FINANCIAL HARDSHIP WOULD PRECLUDE A STUDENT FROM CONTINUING HIS OR HER EDUCATION.

UC SAN DIEGO PROVIDED \$1,000 DISCOUNTS FOR THE 41 REALITY CHANGERS STUDENTS IN 2010.

THE REGULAR COST FOR FOREST HOME IS \$364 PER CAMPER AND THANKS TO DISCOUNTS GRANTED BY FOREST HOME, REALITY CHANGERS PAID \$182 PER CAMPER FOR 110 STUDENTS IN 2010.
